ORDER ON FINAL HEARING, FINAL CERTIFICATION OF FIDELITY
SETTLEMENT CLASS, AND APPROVAL OF FIDELITY CLASS SETTLEMENT

Pursuant to the provisions of the Court's *Order on Plaintiff's Motion for Preliminary Approval, Hearing and Provisional Certification of the Fidelity Settlement Class* ("Preliminary Order"), as well as the provisions of the Notice explaining the pendency of the class action proposed settlement with Defendant Fidelity Exploration and Production Company ("Class Notice") provided to Settlement Class members as provided in the Preliminary Order, a final hearing on the reasonableness and fairness of the proposed settlement in this class action was held on May 8, 2015, at the Fourth Judicial District Court for Sheridan, Wyoming, in Sheridan, Wyoming, before the Honorable William J. Edelman. At the hearing, J. Nicholas Murdock appeared and represented the Class Representative and Settlement Class as Class Counsel, and Beau Bump, appeared and represented the Defendant Fidelity Exploration and Production Company ("Fidelity").

Pursuant to Wyo.R.Civ.P. 23 and 54, the COURT FINDS AND ORDERS AS FOLLOWS:

1. Plaintiff filed a suit against Fidelity alleging individual claims and class action claims seeking, among other things, declaratory, injunctive and compensatory relief. Plaintiff sought certification of a class, including Plaintiff, under Wyo.R.Civ.P. 23(b)(2) for declaratory and injunctive relief, and a class under Wyo.R.Civ.P. 23(b)(3) for money damages.

2. As a result of negotiations, the parties agreed to settle this action on the terms now memorialized in the Settlement Agreement, executed by and between the parties (the "Settlement Agreement"). The Settlement Agreement is attached as Exhibit 1 to the *Stipulated Motion for Preliminary Approval of Class Settlement Agreement and Notice to Potential Class Members* ("Motion"), and is incorporated fully herein. All capitalized terms used in this Order and not defined herein shall have the meanings set forth in the Settlement Agreement. In the event of any conflict between the descriptions in these paragraphs and the more detailed terms of the Settlement Agreement, the Settlement Agreement shall control.

3. This suit involves claims brought under the *Wyoming Royalty Payment Act*, Wyo. Stat. §§ 30-5-301, et seq. including Disputed Deductions Claims, Late Payment Claims, Statutory Interest Claims, Reporting Claims, Litigation Costs Claims and Attorneys' Fees Claims, as those terms are defined in the Settlement Agreement.

4. The Court has jurisdiction and venue over this suit and the Settlement Class. Under Wyo.R.Civ.P. 23(e), approval of this Court is required for any settlement and dismissal of this action.

Certification of the Settlement Class

5. The Settled Claims as defined in the Settlement Agreement all arise from the same nucleus of operative facts and form part of the same case or controversy as alleged against Fidelity in Plaintiff's Complaint so that all of the claims approved for settlement by this Order were or could have been asserted as class claims in this Action.

6. The Settlement Class Members are so numerous that joinder is impractical.

7. There are questions of law and fact common to the Settlement Class Members and Plaintiff and are sufficient to satisfy the requirements of Wyo.R.Civ.P. 23.

8. The questions of law and fact common to the Settlement Class Members predominate over any questions affecting only individual members, and a settlement of Settlement Class Members' Settled Claims by a class action under Wyo.R.Civ.P. 23 is superior to other available methods for the fair and effective settlement and adjudication of the controversy.

9. Plaintiff's claims are typical of the Settlement Class Members' claims.

10. Plaintiff is an appropriate representative of the Settlement Class and has and will fairly and adequately represent the interests of the Settlement Class Members.

11. Settlement Class Members have no special interest in individually controlling the prosecution of separate actions.

12. Class Counsel is experienced and fully qualified.

13. No significant difficulties are likely to be encountered in the management of the action as a class action for settlement purposes.

14. The Court hereby certifies as members of the Settlement Class the list of Royalty Payees set forth in Exhibit I-A to this Order. This list includes all Royalty

Payees who have not opted out of the class by filing a timely notice of their request to be excluded from the Settlement Class. Set forth in Exhibit 1-B is the single Royalty Payee who opted out of the class by giving notification of his election to be excluded from the Settlement Class and has not timely revoked his election.

Notice of Pendency of the Class Action Proposed Settlement And Hearing

15. Pursuant to the Preliminary Order, and Wyo.R.Civ.P. 23(e), Class Counsel provided notice to the parties listed on Exhibits 1-A and 1-B informing them of the compromise and settlement reached in this action via the Class Notice. A copy of the Class Notice is attached as Exhibit 2 to the Motion and is incorporated fully herein.

16. According to the *Report on Status of Class Notice Pursuant to Wyo.R.Civ.P. 23(c)(2)* filed with this Court by Class Counsel ("Class Counsel's Report"), the Notice was sent via *United States Postal Service Priority Mail* to all parties listed on Exhibits 1-A and 1-B. *Class Counsel's Report* confirms no objections were filed to the Class Settlement and the Royalty Payees on Exhibit 1-A remained as Settlement Class Members with only one (1) owner opting out.

17. Reasonable and adequate notice of the certification of the Settlement Class and the settlement of the Settlement Class Members' Settled Claims was given through mailing of the Notice as approved in the Court's Preliminary Order.

Approval of the Settlement Agreement

18. The settlement was made in good faith.

19. The Settlement Agreement constitutes a fair, adequate and reasonable settlement of all Settled Claims.

20. This Court finds after considering all the circumstances that the Settlement Agreement is fair, equitable and reasonable and should be approved.

21. This Court finds after considering Plaintiff's Points and Authorities Addressing Attorney's Fees in Common Fund Class Action Cases as well as Class Counsel's Application for Attorney Fees and Class Representative's Award that the fees requested are fair and reasonable.

NOW, THEREFORE, IT IS HEREBY ORDERED, ADJUDGED AND DECREED THAT:

a. The Settlement Class Members listed in Exhibit 1-A are certified as a class under Wyo.R.Civ.P. 23 for purposes of settlement only of Settled Claims, and shall proceed with settlement as provided in this Order and the Settlement Agreement;

b. As of the Approval Event, any Settlement Class Member who has not timely and properly opted out of the Settlement Class shall be deemed, by that fact, to have released Fidelity and Fidelity Additional Parties from all Settled Claims as provided in the Settlement Agreement whether or not the Settlement Class Member endorses and presents a Distribution Check;

c. Following the Approval Event, each Settlement Class Member as defined shall become fully bound by all of the releases of Settled Claims and fully bound by other obligations and conditions as set forth herein and in the Settlement Agreement;

d. Following the Approval Event, Fidelity shall become fully bound by all of the releases to each Settlement Class Member and Fidelity shall fully bound by other obligations and conditions as set forth herein and in the Settlement Agreement;

e. Except as necessary to enforce this Order and the Agreement, Plaintiff, Settlement Class Members and their heirs, assigns, and successors are forever barred from

bringing claims against Fidelity or Fidelity Additional Parties for Settled Claims as set forth in the Settlement Agreement.

f. Fidelity shall wire transfer the Fidelity Payable Settlement Sum in the amount of Three Million Five Hundred One Thousand Sixty Eight Dollars and Eighty-Nine Cents (\$3,501,068.89) into an IOLTA trust account at the First Interstate Bank, Casper Branch ("Trust Account") in accordance with the Settlement Agreement. The Fidelity Payable Settlement Sum is available for distribution in accord with the provisions of this Order.

g. The Fidelity Payable Settlement Sum has \$1,500.00 in interest to be distributed. All such interest should be payable to Settlement Class Members. Class Counsel will receive no portion of the sum attributable to that interest.

h. The aggregate amount to be paid from the Fidelity Payable Settlement Sum to Plaintiff and Settlement Class Members, including interest, is and shall be Two Million Four Hundred Twenty Nine Thousand Eight Hundred Seventy Four Dollars and Twenty One Cents (\$2,429,874.21) ("Settlement Amount"), which amount shall be paid to Class Members or their heirs, successors or assigns by Class Counsel in the amounts as set forth in Exhibit 2 to this Order.

i. The reasonable fees and costs of Class Counsel are and shall be One Million Seventy One Thousand One Hundred Ninety Four Dollars and Sixty Eight Cents (\$1,071,194.68) ("Permissible Class Counsel Fees"), which amount shall be paid to Class Counsel. Included in Permissible Class Counsel Fees are Administration Costs, Litigation Costs and the fees and costs to the Class Representative.

j. Upon entry of this Order, and satisfaction of the Approval Event, as that term is defined in the Settlement Agreement, Class Counsel shall commence payment of the Fidelity Payable Settlement Sum from the Trust Account for the amounts to be distributed to Settlement Class Members, Class Representative Fees and Expenses and the Permissible Class Counsel Fees. No portion of the Fidelity Payable Settlement Sum will be paid to Potential Class Members listed in Exhibit 1-B to this Order who have requested to be excluded from the Settlement Class.

k. After payments from the Trust Account, any amounts unable to be paid to Class Members will be paid into an escrow account established in conformity with Wyo. Stat. § 30-5-102 in accordance with the timing and other requirements of the Settlement Agreement.

l. The Court shall retain jurisdiction to the extent provided in the Settlement Agreement.

m. Upon entry of this Order, and satisfaction of conditions for the Approval Event, as that term is defined in the Settlement Agreement, the Reserved Claims as that term is defined in the Agreement will be deemed severed from the Settled Claims and will be dismissed without prejudice.

n. Upon entry of this Order, and satisfaction of the conditions for the Approval Event, as that term is defined in the Settlement Agreement, Class Counsel and Defendant shall file a stipulated satisfaction and order of dismissal with prejudice of all Settled Claims as defined in the Settlement Agreement. The order of dismissal with prejudice of the Settled Claims shall be entered by the Court and shall be considered a final appealable order under Wyo.R.Civ.P. 54. To the extent such may be necessary in


light of the Reserved Claims, this Order is hereby certified as final and appealable under Wyo.R.Civ.P. 54(b).

o. This Order pertains to royalties paid for production from the Fidelity Wells identified on the list attached to the Settlement Agreement as Exhibit B.
